

**PRATT COUNTY UNIFIED DISTRICT DESCRIPTION**  
**UNIFIED DISTRICT #382 (PRATT COUNTY)**

Beginning at the NW corner of section 2, T26S, R13W, thence east along the Pratt-Stafford County line 1 1/2 miles, thence south and east and north to exclude the N 1/2 of lots 1 and 2 of the NE 1/4 of sec. 1-26-13; and to exclude all of 3 & 4 of the NW 1/4 of sec. 6-26-12; east to the NE corner of the NW 1/4 of sec. 5-26-12; thence south to the SW corner of the SE 1/4 of sec. 5-26-12; east 1 mile, north to center of section 4-26-12; thence east 3 miles, south to the center of sec. 12-26-12; thence east 1/2 mile, north 1/2 mile, east 2 1/2 miles, east 2 1/2 miles, south 1/2 mile, east 1 mile to the center of sec. 10-26-11; thence south 1/2 mile, east 2 1/2 miles, south along the Pratt-Reno and Pratt-Kingman County line 6 miles, west 2 miles, south 1/2 mile, west 1/2 miles to the center of sec. 16-27-11; thence south 3 miles, west 1 mile, north 60 rods, west 80 rods, south 50 rods, east 46 rods, south 60 rods, west 46 rods, south to the SE corner of the SW 1/4 of sec. 32-27-11; thence west to the extended east line of Block 29 in the City of Cairo, north to the NE corner of Block 27, west to the NW corner of Lot 12, Block 16, north to the NE corner of Lot 14, Block 16, west to the NW corner of Lot 14, Block 16, east to NE corner of Block 16, north to the south boundary line of the A.T.&S.F. Railroad right-of-way; thence east 200 feet, north to the north boundary line of said right-of-way, west to a point 853 feet east of the railroad intersection with the county road; thence north 100 feet, west 623 feet along the north line of the Cairo Co-op property, north 85 feet, west 230 feet along the Cairo Co-op property line to the county road, south to the SW corner of the NW 1/4 of sec. 5-28-11; thence east 2 miles, south 1/2 mile, east 1/4 mile, south 1/2 mile, east 1/4 mile to the center of sec. 10-28-11; thence south 1/4 mile, east 1/2 mile, south 1 1/4 miles, west 1 mile, south 1/2 mile, west 2 miles, south 1 1/2 miles to the SE corner of sec. 30-28-11; thence west 2 miles, south 1/4 mile, west 1/2 mile, south 3/4 miles, west 2 miles, north 1/2 mile to the center of sec. 33-28-12; thence west 2 1/2 miles, north 1 1/2 mile, west 1 1/2 miles, south 1/2 mile, east 1 mile, south 1 1/2 miles to the SW corner of the SE 1/4 of sec. 36-28-13; \*thence west 3/4 mile, north 1/2 mile, west 1/4 mile, south 1/2 mile, west 2 1/2 miles to the SW corner of sec. 33-28-13; \*\*thence south 1 1/2 miles, west 1/2 mile, south 1/2 mile\*\*, west 1/2 mile, north 1/2 mile, west 1/2 mile to the center of sec, 7-29-13; thence north 1/2 mile, west 1/2 mile, north 1/2 mile, west 1 mile, north 1 mile, east 1 mile, north 1/2 mile to the NE corner of sec. 36-28-14; thence west 1 mile, north 3/4 mile,
